

#### PART VI

The Applicants and its board of directors believes in honesty and transparency and reserves the right to alter these bylaws at their discretion. The revised bylaws will go into effect 30 days after board approval.



1a. The board reserves the right to alter any new changes within the 30-day period, and the new changes will take effect on the original 30-day period.

1b. The board will permit public input which could include but is not limited to.

- General Public
- Volunteer and Paid

2a. The organization will provide all volunteer and paid employees *if any* with board approved or denied changes and a detailed description of why the changes were or were not approved, and how the changes will impact the organization.

2b. The detailed description will be provided within a 2-week period of the approved or denied changes to all employees. The board will make available the detailed description to anyone in the public by adding the detailed description on its website and social media pages.

2c. The public can request a paper copy of the detailed description if they would like one. There will be a \$5.00 fee for anyone who would like a burned copy of the boards detailed description on a CD or flash drive. In addition anyone volunteers and/or the general public can request a copy be emailed via a attachment and/or Dropbox link.
